A Narrative Budget is a way to lay out the churches spending plan in a way that shows how the budget aligns with and supports the mission of BLC.


The spending plan will be broken down by our five core ministry areas:

## Narrative Budget




Our spending plan for 2021, aligned to our five core ministries is represented below





## Updates to BLC Constitution

#### **ELCA Model Constitution and BLC**



- Churchwide Assembly updates the model constitution once every three years
- ■Updates were approved in the August 2019 Assembly
- ■BLC adopted the ELCA model constitution in 2017
  - Constitution contains 20 Chapters, 14 of which may not be altered by Congregations

#### Amendments for 2020



- Churchwide Assembly authorized the ELCA secretary to make the following changes
  - Strike "synodical" and replace with "synod"
  - Strike "the congregation" and replace with "this congregation" where appropriate
  - Make changes so that model constitution follows the ELCA and Synod constitutions
- Majority of the changes are in chapters that may not be altered by Congregations (75%)

### Change not related to ELCA



- ■BLC Council previously agreed to change the treasurer role to an officer position
  - Requires change to the bylaws of the constitution
- Treasurer's duties moved from bylaw C11.04.02 to bylaw C11.02.01
- ■This change can be approved at any BLC congregation meeting
